## **Unfolding and decisions:**

- 2. **Activity report**. The activity report was presented by the Board Chair, Melania Borit. Henry Pinedo (NT) raised the following issues (after -> follows the reply of the Board/AGM):
  - a. What were the suggestions of the TODOS Board to the change of the UiT Election rules -> this document was written more than half year ago, so no Board member could remember in details about these suggestions; if anybody is interested in these, details are available at request. Moreover, all official documents sent by TODOS will be soon available on the website.
  - b. The small number of social events -> there was one activity at each 2 months and this was considered fine by the AGM.

- c. The lack of details in the Budget presentation -> at the 2012 AGM the budget was presented in detail and present persons did not show any interest in it, therefore this year it was decided to present a shorten version of the report. If anybody is interested in details, these are available on the TODOS website and can also be given at request.
- d. The small number of persons present at the AGM -> the AGM decided that the Board advertised the event properly and it is not the fault of the Board that people decided not to join it.
- 3. **Elections.** Before the elections started, the AGM voted the following:
  - i. As an exception for this AGM, persons not physically present can be elected in Board position: this decision was taken with unanimity;
  - ii. As an exception for the 2013 Board, the number of regular board members to be increased from 2 to 4 (there were 4 persons who wanted to candidate on 2 positions and the idea was to allow everybody who wants to contribute in the Board to do it and get recognition for it): this decision was taken with 8 votes for, 2 votes against and 2 abstains.

For all the positions in the Board there was only one candidate, therefore this candidate was elected without voting. The new Board is composed as follows:
